COA

Cost of attendance (COA), as dictated by Congress, is the estimated average cost to attend an institution for one academic year. It includes tuition and fees, books and supplies, room and board (living expenses), transportation, and personal expenses. The Financial Aid Office adjusts the COA yearly to reflect changes to those costs.

The COA is a calculation component for determining financial aid assistance. COA calculations are based on full-time attendance enrollment in clock hours at the in-state tuition rate of \$2.92 per clock hour.

WTC provides a separate COA for dependent and independent students based on the assumption that dependent students typically have lower room and board.
